**RECOGNITION ORDER**

AND WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 1.12.2014.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 251<sup>st</sup> meeting held on April 30-May 2, 2016 was satisfied that the Institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. programme, such as Infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to D S MAHAVIDYALAYA, RUN BY D S PRIHAR MANAV VIKAS AVAM SHIKSHA SAMITI, PLOT/KHASRA NO.1/2 KH/2, STREET NO. JHONPA, VILLAGE - POST ARGAT, POST OFFICE - TEHSIL NEW RAMNAGAR, TEHSIL/TALUKA - BLOCK NEW RAMNAGAR, TOWN/CITY - JHONPA, DISTRICT - SATNA, PIN CODE 485881, MADHYA PRADESH for conducting D.El.Ed. programme of 2 (Two) years duration with an annual intake of 100 students (two basic units of 50 each) from the academic session 2016-2017.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.



The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.



- Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- Fee charged from students;
- Available Infrastructural facilities;
- Facilities added during the last quarter;
- Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information. If it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provisions of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act, 1993.
